The EMS Academy is a fasted paced/excelled program: The class is Monday through Friday and is an **(8) eight to (10) Ten-week paid training and education program** for individuals interested in starting a career in the Emergency Medical Services field as an Emergency Medical Technician (EMT).

- **Hired full-time by EmeryCare upon successful completion of Academy and passing (2) two examinations.**
- **In addition to the paid training, this position offers medical and retirement benefits.**

The EMT is fully responsible for functioning within the Pennsylvania Emergency Medical Services (EMS) Basic Life Support (BLS) Scope of Practice and is accountable for the quality of emergency and non-emergency medical care delivered. In delivering pre-hospital care, the EMT performs all basic life support techniques, provides specified field treatment for medical / traumatic emergencies and transports patients to the appropriate medical facility via ambulance. In addition to ambulance transportation, the EMT also is required to provide medical transportation by paratransit van or by medical taxi as permitted by the Public Utility Commission.

EMTs conduct patient assessments to assess the nature and extent of illness and / or injury to establish and prioritize medical procedures to be followed or need for additional assistance and provides basic life support to all patients, adhering to established protocols, organizational procedures, and the PA DOH EMS Scope of Practice.

Responsibilities:

- Actively participate in a paid eight-week intensive classroom and clinical field EMT education.
- Maintain a course average of 70% or higher throughout the course.
- Obtain Emergency Vehicle Operation certification (PA DOH EMSVO Certification) within three weeks (21 calendars days) from the first day of the program.
- Obtain PA Department of Health Emergency Medical Technician Certification (PA DOH EMT certification) within eight weeks (56 calendar days) from the last day of the course.
- Act as an Emergency Vehicle Operator as needed.

Requirements:

- Be at least 18 years of age
- Possess a high school diploma or GED
- Be fluent in the English language – Must be able to read, comprehend written materials, interpret spoken information, and effectively communicate via in writing and in person, the English language, telephone, telecommunications, and other electronic devices.
- Be able to stand frequently; walk; sit; use hands to fingers, handle or feel; reach with hands and arms, climb or balance; stoop; kneel or crouch.
- Ability to frequently lift and/ or move more than 100lbs.
- Possess Valid Driver's license with no license suspension in the past two years or DUI convictions in the past four years
- Cannot have been convicted of a crime greater than a summary offense that would prevent obtaining a Dept. of Health, Bureau of EMS Certification in the Commonwealth of Pennsylvania.
- Be able to pass a post offer drug test screening
- Cannot have been excluded or listed as ineligible to participate in Medicare, Medicaid, or other Federal programs
- Must be able to pass the following background clearances post offer:
 - Act 151 Childline Child Abuse Clearance
 - Act 114 FBI Fingerprint Clearance
 - Act 34 PA Criminal History Clearance
- Be able to work for EmeryCare Full Time as an EMT for at least one year. Two-year commitment required if taking \$3,000 sign on bonus on completion.
- Effective computer skills
- Ability to follow oral and written instructions
- Ability to exercise sound judgment while working in a stressful environment
- Participation in the Coronavirus Disease 2019 (COVID-19) Vaccination program under the Federal Government Mandate is a requirement.

Hours: 32 hours a week- 28 hours of classroom and lab instruction, 4 hours of clinical/street experience /Study/Tutoring/Test prep time.
